Everything That's Excellent?

FROM TIME TO TIME at the beginning of the season players discover (quite often to their cost) that there has been a change in the Laws. Indeed the Laws

of Croquet seem so unlike the lbw law, a change in which is always good for a four-inch headline, that many Associates may wonder how the changes come about, and indeed, whether they have any say in the matter. If this is so, it is rather serious. For though Council is in general (though not always - sometimes a letter in Croquet sets the ball rolling) instrumental in proposing amendments or alterations to the Laws, Associates are given the opportunity to vent their feeling on the question. The full procedure is laid down in Rule XIV of the Association (page 9 of the Handbook). Council are first required to pass a resolution proposing the adoption of the desired change. The resolution must then be published in Croquet (recently many such resolutions have appeared as part and parcel of the Council report). And then, not less than a fortnight later, Council must have a special meeting to ratify the proposal, and at such a meeting a two-thirds majority is required. Now clearly the publication of the resolution, and the subsequent fourteen days grace are designed for those Associates who may have some objection to the proposal, and an Associate might well be encouraged to write to the Secretary if he ever finds himself in such a position. For there are perhaps many others who think as he does, and the strength of their combined protests may well force Council to reconsider the whole problem, and indeed may lead to the idea's being dropped altogether. Council would hardly adhere to its intention and ratify the proposal in defiance of a strong public outcry. But it may, unwittingly, be ratifying alterations of which hardly anywhat they can do. It is to be hoped that this is not the case.

Our New Face

ONE OF THE first things Associates will have noticed on opening the current number is that the form of the magazine has changed. Our magazine

is in fact no longer being printed in the traditional way but is now being lithographed, and some words by way of explanation of this change are appropriate.

Council, and particularly those members responsible for the Associations finances, have long been concerned at the cost of the magazine. A publication of this nature, with such a limited circulation, has little appeal for advertisers, and consequently the cost of publication falls to be met almost entirely out the Association's funds. The Holmesdale Press, our printers from the very beginning of the magazine's history, have, for what can only be described as sentimental reasons, been generous enough to continue for some time to print our journal at considerably less than an economic price, and for this we have been most grateful. But sooner or later we are all faced with economic realities, and even Holmesdale were compelled this year to raise the price at which they were willing to print for us. Although from their point of view this only meant that they were for the first time proposing to charge a realistic price, from our point of view it was felt to be more than we could reasonably afford. We were, therefore, com-

pelled to look around. This we did with great reluctance, for many reasons. For if sentiment has influenced Holmesdale, it influenced us even more. It is never a pleasant moment when the time comes to sever a tie which has existed for over 50 years, particularly when that period embraces the whole life-span of an enterprise, and when the relationship has throughout been so happy. Moreover, we cannot forget the fact that Holmes-dale stood by us in 1964 after their entire premises had been destroyed by fire; for in spite of this they continued to publish our gazette, a very minor item in their whole clientele, as if no fire had ever occurred. For this, we will always be grateful.

Nevertheless economic realities must be faced, and when investigations revealed that the necessary economies could be effected if the gazette were produced by the litho process, we were very glad to be able to accept the offer of Prestoprint Limited to publish the gazette for us. We hope that this number will see the beginning of a long and happy relationship.

It is, perhaps, worth mentioning at this stage that the new process might well afford us more freedom than before in the nature of the subject-matter printed, and that the Editor will now be able to entertain with an open mind, instead of having to reject out of hand on the ground of expense, copy in forms other than the written word: in particular, contributions containing sketches, provided they are submitted in a form ready for immediate photographing can now be considered. For this reason, among others, we hope that the new format will be not only a change but also a face-lift.

Eights Week

ASSIDUOUS READERS of this journal will have noticed in our December issue the disappearance from our Calendar of a familiar fixture, the Ladies Field Cup, and the intrusion of a new one for the week of Septembe 5th sandwiched, if that is not too impolite a term, between the President's and the Surrey Cups. But the placing of the new Chairman's Cup precisely indicates the position this competion has been devised to occupy, for we are now to have what the Surrey Cup was sometimes, but always quite incorrectly, described to be, a second Eight - and indeed a Third, for the Surrey Cup is now designed to occupy such a position. Some may regret the 'suspension' (for that is the correct description of what has been decided) of the Ladies Field Cup which for so many years after its initiation in 1911, not only provided a strong incentive for improving players of that sex, but produced a high standard of performance; all the greatest names on the feminine side of the game appears on the trophy. But there are no longer, alas, enough of such persons, and it is known that the best of these there are, if they fail to regain places in the Pre-sident's Cup, would much prefer to compete in a second Eight, or even possibly a Third one. There may be some who will regret that former members in our "Best Eights" may now perhaps be found flaunting their colours in less exalted company at Cheltenham, if they feel it not "infra dig" to do so. We have little doubt, however, that as many young men as ever will be seen winning their spurs in the Surrey Cup on their way, as before, to yet higher things.

The 1966 Season

S EASON 1965 as regards weather was very bad, but despite it most tournaments had about their usual number of competitors. It is to be hoped that this year will produce much more sunshine and that all players will be able to enjoy their games.

There are three alterations of tournament dates. Carrickmines will be a week earlier than usual and Ryde a week later, and at Southwick the second non-official will once again follow their official tournament. There are seven week-end tournaments: five at Cheltenham, one at Hun-stanton and one at Woking. These seem to become more popular every year. The Mens and Womens Championships will not start until Tuesday May 31st as Roehampton are not able to prepare the lawns for the preceeding day (Whit Monday), but the Club are willing for this meeting to continue until Sunday if necessary. The Evening Handicap Singles will start on Wednesday June 1st: please see advertisment in this magazine. The Challenge and Gilbey Tournament will start on Monday July 11th and will be played as an American Handicap Singles in blocks according to handicaps, with a three hour time limit. This means that all competi-tors will get at least five games during the week. The Block Winners will be drawn on the Bagnall-Wild System and will play off for the four Challenge Cups. The second highest score in each block will also be drawn on the same system and will play off for the Gilbey Cup and the three supplementary cups. The Golf Cro-quet events will be included in the Hurlingham Tournament and we expect most of the games will be played at Roehampton.

The Ladies Field Cups competition is to be suspended for 1966, but there will be three events for the best 24 available players invited to compete by the Council of the Croquet Association for the following:

(1) The President's Cup to be played at Hurling-

(2) The Chairman's Cup to be played at Hunstan-

(3) The Surrey Cup to be played at Cheltenham. This will mean a great deal of work for the Selection Committee, so may I urge all players who receive invitations to answer these without delay, as the Committee will need all the time that competitors can give them to make the necessary arrangements.

The Council have decided to lower the lowest limit of handicaps from -3 to -5, and this should please those associates who wrote on the subject to the magazine. May I suggest all Associates should apply to the Secretary for at least two copies of Mr. Solomon's "Instruction to Begin-ners" (price 1/-). They are very good and a splendid way of approaching possible new players, as they are so easy to understand and may well encourage them to become Associates in 1966. I also ask those players who have not (price 1/6d) to write for one to help them better to understand the laws of croquet.

The Longman Cup proved a great success again in 1965, and we hope more Clubs will enter this year and so enjoy matches with other Clubs, as this will help croquet to be better known through out the country. There are several new Clubs being started this year and they will need as much help as can be given them. The best help possible is from another Club in the vicinity, so may I ask Associates to give generously of their

The Council have decided not to make a strict division in the two weeks at Eastbourne in 1966, but to play it as a fortnights tournament with one Manager; it will be made clear that if a competitor can only stay for the first week, any finals that he or she is concerned in will be played, not later than the first Saturday. The second week's events will start on the second Monday. Event 3 (Level Singles) will be open to competitors from $3\frac{1}{2}$ to $6\frac{1}{2}$. Event 4 and 5 will be amalgamated and will be played as Handicap Singles, open to competitors handicapped at 7 bisques and over. The Restricted Handicap Singles in the second week will be played as Draw & Process. The Secretary asks all competitors to use seperate entry forms for each week, and so save mistakes in the event numbers, which have been allocated this year. Exhibition matches will be played on Sunday Oct. 2nd at 2.30 p.m. The Council very much hope that all competitors at the tournament will give as much help as possible and so make the afternoon a success.

As Chairman of the Tournament Committee I would like to make an appeal to all competitors at Eastbourne in 1966, to try to make this a much more pleasant tournament than it has been for the past few years. I have been down two or three times each year during the fortnight, and I have received a good many complaints. I wonder how many competitors even think or realise realise what a considerable undertaking it is for the Manager and the Secretary to keep things running smoothly, but I know they would be the first to admit that sometimes mistakes can and do occur. There are of course, players who are always ready to give a helping hand whilst others just wait for everything to be done for them and then criticise. If competitors would be ready to play when required by the Manager, and ask for as little leave as possible, this would indeed make things easier for the Man-ager. So many requests for leave were made on both Mondays last year, that the Managers found great difficulty in filling the lawns, and in consequence difficulties arose later in the week. I think competitors should remember that the Manager and the Secretary are both there at great expense to themselves, and they should be given every consideration. I fear that unless this happens we shall lose Manager, Secretary and competitors at this meeting, and this we can ill afford to do. Some years ago I heard a player say that if she could only go to one tournament during the season, she would choose Eastbourne. Please let us see to it that this can be said again this year.

THE BALANCE SHEET and Accounts for the past year which will be found inserted in the magazine reveal a satisfactory financial position. In other respects too, the year may be regarded as laving proved successful

The radical change from five or six weekday Council Meetings commencing at 2 p.m. at Southampton Row to three Meetings on Saturdays commencing at 11.45 a.m. at the Hurlingham Club, met with general approval, and, thanks to the co-operation of the various Committees in arranging the dates of their own Meetings, all necessary business was satisfactorily dispatched. Reports of Council Meetings not previously published are printed elsewhere in this issue

Two small booklets, "Laws of Croquet Simplified" by A. E. Roper and "Instructions to Beginners" by John Solomon, published last year, are enjoying much success and proving of considerable financial benefit. Large orders have been placed by Australia, New Zealand and South Africa.

As from April this year the magazine is being produced by 'litho' process, and published by Prestoprint Ltd. The resulting economy in production cost together with the increased advertisement revenue, which it is hoped to obtain, should be of real financial benefit.

As you will see from Reports of Council Meetings efforts have and are being made to produce an Instructional Film, arrangements for holding a special Centenary All-England Handicap in 1967 are under consideration, and a Challenge for the MacRobertson Trophy in 1969 has been received from Australia. The success of the season was greatly enhanced by the presence of our Australian friends Mr. & Mrs. Rutland, Colonel Saalfeld and Mrs. Gazzard. It was a cause of great pleasure to all players that Col. Saalfeld should have been invited to play in the Surrey Cup, and Mrs. Gazzard in the Ladies Field Cup, but a matter of real regret to everyone that a bad fall the day before, prevented her doing herself full justice in this competition. One of the few failures in the year was the Old Boys Tournament, which had to be cancelled owing to lack of entries. The Navy is, of course, indo-mitable and Cmdr. Borrett has not given up. He has initiated a Register of Schools, Colleges, Regiments etc., in which it is hoped ALL Associates will register their qualifications, even if unable to play in the Tournament this year.

In May Miss Lintern retires from the Chairmanship of the Tournament Committee in accordance with Standing Order 26. I am sure all Associates would join with

Report of the Council

SPECIAL MEETING HELD AT HURLINGHAM, ON THURSDAY, 5th AUGUST, 1965.

1. The Chairman reported that the Association had been approached by Town & Country Productions Ltd., a non-profit making concern, specialising in productions of films of this nature, suggesting the production of a film on Croquet. The film would be in black and white and run for approximately 20 minutes. Advertisement and distribution would be undertaken by Town & Country Productions Ltd. Similar films on most sports and games had been produced and sponsored by some of our leading Commercial Firms. If the idea was approved it would be necessary to obtain a Sponsor willing to finance the production and advertisement costs, approximately £1,400. Council approved the idea, and it was decided to approach Messrs. Guiness first as possible Sponsors.

2. The debate adjourned from 24th May was resumed and it was agreed to vary Standing Order 1 and curtail the eight Meetings scheduled to be held between October 1965 and April 1966, at Southampton Row on Thursdays, commencing at 2 p.m., to three meetings to be held at Hurlingham Club on Saturdays, commencing 11.45 a.m.

MEETING HELD AT HURLINGHAM CLUB ON SATURDAY, 13th NOVEMBER 1965.

1. The Council accepted with regret the resignation of Colonel J.G. Clarke tendered as a result of him now living in Cornwall.

2. On the proposal of Miss Lintern seconded by Mr. E.A. Roper, Council approved the adoption of the Tournament Committee's Report dated 28th October 1965 and made the following decisions:

- That all best of three games should be limited to 9 hours. That, since all games in the 1966 Hurlingham Tournament (ii) would be played subject to a 3 hour time limit, the Ladies Field Candlesticks in 1966 would be played under similar conditions.
- (iii) That there shall be no restrictions on minus players entering for handicap events.
- That the Challenge & Gilbey Tournament be played in blocks as an American Tournament, first and second in each block to play off for the Cups. The Hurlingham Club to be asked to include the Golf Croquet events in the programme of their Tournament.
- That in 1966 there shall be three Invitation Eights but that the Ladies Field shall be abandoned for one year.
- (vi) That the programme for the Devonshire Park Tournament be amended as follows:-(a) Events 4 and 5 to be amalgamated.

(b) Limit of Event 3 to be raised to $6\frac{1}{2}$ bisques. New combined 4 and 5 event to start from 7 bisques.

- (c) Restricted handicap to be played on the 2 Life system (d) Tournament to be played as a fortnight's competition. If a competitor was only able to stay the first week any finals in which he or she were concerned to be played not later than the first Saturday. Second week events to start on Second Monday.
- (vii) That there should be an Old Boys Event.
- 3. Mrs. Rotherham and Mr. Caporn were elected Managers.

4. Recommendation of Handicap Committee to lower the lowest limit of -3 to -5.

5. On the proposal of Mr. Rivington seconded by Mr. Duffield Council approved the Finance & General Purposes Committee's Report dated 1st February 1966 and made the following decisions:-

- (a) That the interim Statement and Estimate be accepted
- (b) That the usual gratuities be paid to groundsmen

(c) That the unexpended balances of funds allocated to the Publicity Committee for expenditure for any financial year, cannot be carried forward

(d) That the Editorial Panel be instructed to consider methods of reducing the cost of the Magazine

6. Correspondence with Messrs. Jaques regarding complaints about unusable balls was considered. To try and obviate these in future it was decided to ask Clubs to comply with Messrs. Jaques' request, and give as long notice as possible when ordering balls.

7. Subject to Messrs. Jaques being able to supply four sets of their new design of Eclipse Balls it was decided that these balls should be tried out at the Peel's and Men's and Women's Championship.

8. Council accepted with grateful thanks Miss Steel's offer of her late sister's Rose Bowl, and decided to award the Rose Bowl to the most improved woman player each year - the Apps Bowl to be awarded to the most improved man player each year.

9. The following awards were approved:-The D. D. Steel Rose Bowl for the most improved woman player in 1965 Mrs. L. Riggall.

The Apps Memorial Bowl for the most improved man player in 1965 Cmdr. G. Borrett.

The Club deserving of most recognition Parkstone. COUNCIL MEETING HELD AT HURLINGHAM CLUB ON SATURDAY, 22nd JANUARY 1966.

1. Information was received from Messrs. Jaques that not only would they provide their new design balls for the Peels and Men and Women's Championship but they would on request send sets to all the large Clubs for trial and report.

2. An offer of their Club as a venue for an Invitation Event was received from Colchester. Council expressed their thanks and hoped to avail themselves of the offer in due course.

3. On behalf of the Nottingham Club, Mr. Birch raised the question of whether a player who has played in an American Tournament on a particular handicap should continue to play all through the Tournament on that handicap irrespective of whether or not it had been altered. Although it has been established that the Association has no power to interfere or rule on Club private events Council are always willing and ready to advise. but before doing so in this case referred the matter to the Laws Committee for review and report.

4. A special grant of £20 to the Publicity Committee for the purchase of a display stand was approved.

5. On the proposal of Mr. Rivington seconded by Mr. Birch the adoption of a report of a special Sub-Committee, composed of Mr. Caporn, Dr. Wiggins, Mr. L. E. W. Stokes-Roberts and Miss Lintern, and convened to consider the form of celebrating the Croquet Centenary Year, 1967, on a National Scale, was agreed. In principle the suggestions were approved unanimously, and the recommendation that travel and overnight expenses to area finalists be payable by a majority of 9 to 6.

6. Magazine

Council received recommendations from the Editorial Panel and made the following decisions:-

- (i) In view of the considerable economy that would be effected thereby to transfer to litho printing for the magazine. That the Editor be given the following instructions:-(ii)
- (a) No issue to be less than 12pp (b) Wherever possible to include in each issue at least
 - one article of intelligent propoganda and literary merit.
 - (c) To prune Reports of Tournaments where possible, but not to curtail Results.
- (iii) That every effort should be made to increase advertisements and that the front page could be used for suitable advertisements

7. MacRobertson Trophy.

The Chairman reported receipt of a Challenge from the Australian Croquet Council. The contest to be played in 1969 in Australia. The Secretary was instructed to write to the Australian Croquet Council accepting the Challenge subject to the venue

being mutually agreed, but suggesting that this series be played here in England and the following series in 1975 in Australia, as 1975 would make the Jubilee year of the Contests which were inaugurated by an Australian player who also presented the Trophy.

MEETING HELD AT HURLINGHAM CLUB ON SATURDAY 26th FEBRUARY 1966.

1. Sponsors for Instructional Films.

Agreed that in the event of the reply from Messrs. Guinness proving unfavourable an approach should be made to Messrs. Figone

2. Expenditure by Publicity Committee.

Authority granted to Publicity Committee to spend up to £50 during the current year. Any grants made to Clubs must be solely for expenditure made by them on publicity. All other grants being matters of recommendation by the Treasurer and F. & G. P. Committee, or in cases of emergency at the discretion of the Chairman in consulation with the Hon. Treasurer.

3. Report of F. & G. P. Committee.

The Hon. Treasurer presented and explained the Accounts and Balance Sheet for 1965. On his proposal and seconded by Major Dibley, the adoption of these was unanimously approved.

In dealing with the remainder of the report, the Hon. Treasurer referred to the necessity to muster and revalue the Associations' trophies, and to the steps to be taken in this connection. On his proposal and seconded by Miss Lintern the adoption of the report was unanimously approved.

4. Report of Laws Committee.

On the proposal of Mr. J. Solomon seconded by Mr. Birch a report of the Laws Committee dated 15.2.66. was adopted and the following Resolutions unanimously approved.

- That a Sub-paragraph (g) be added to Law 38 "At the con-(i) clusion of a turn the striker must give a clear indication of his intention before taking a bisque or half bisque. If he fails to do so but continues to play the provisions of Law 27 shall apply. When all balls have been replaced the striker shall have the option whether or not to take a bisque or a half bisque.
- That the following shall be added at the end of Regulation 22(a) "but in any event which lasts for two weeks or longer a player shall play at his current handicap."
- That the trial of Umpires last season was not considered full enough to be worthy of forming the basis of an opinion and the Committee recommend that it be continued for a further year.

Council further approved

- That the powers of Umpires be extended to include (i) whether or not a ball has run a hoop or is on or off the Court.
- That it should be indicated in the magazine that, whereas (ii) the Amendment to Regulation 22(a) only applies to events played under Official handicaps, and is not intended to remove the right of Clubs to manage their own affairs, Council do recommend that similar procedure be adopted when events are played under Club handicaps.

5. A.G.M. 1966.

The following details were approved. Date 23rd May. Time: 2.30 p.m. Venue: The Hurlingham Club.

6. Conference of Associates 1966

Date provisionally approved as 12th November: Time: 2.30 p.m., Venue: The Hurlingham Club.

7. Mr. Rivingtons' motion that Standing Order 4 be amended by adding the words "but shall be eligible for re-election after an interval of 5 years" was approved, Mr. Reckitt and Mr. Miller dissenting.

Notes from the Clubs

Budleigh Salterton.

The Chelmsford and Colchester Croquet Club.

This new club has been formed this year by an amalgamation of the former Chelmsford and Mid-Essex, and Colchester Clubs. Both grounds will be fully maintained as before and activities will we hope be expanded rather than curtailed. A number of players have been members of both the former clubs and it was felt that there would be social and administrative advantages in running the clubs as one unit.

We have seven courts available, four at Colchester and three at Chelmsford. With upwards of fifty playing mem-bers we look forward to a successful season.

Roehampton.

At our A. G. M. held in late November we were delighted that Mrs. C. C. Adams was not only able to be with us to present the prizes, but that she and her family gave us a fine silver cup, in memory of her dearly loved husband whom we miss so much, not only at Roehampton but in the Croquet World in general.

This cup is awarded to the runner up of our Club American Singles Tournament which means that it can be won by either a high or low bisquer who has first of all not only to win his or her block but also a play off as we have 4 blocks. The Committee gave long and very careful thought to whom should be able to win this special cup and felt that it would have been the late Colonel Adam's wish that all members of the Club should be able to compete for it and not just one particular class of player.

We are deeply grateful to Mrs. Adams and her family for this lovely trophy which will be greatly prized by all who win it. Our chairman, Mr. Gilbert gave his report and also expressed everyone's regret that Brig. and Mrs. Omond were leaving the Club as they were mov-ing but was glad to hear that they would be able to join the Woking Club. Miss D. A. Lintern, our Captain, then reported on the events of the past season, congratulated all winners of the Club events and in particular Mr.R.F. Thorp, for being selected to play in the Presidents Cup and Professor B. G. Neal and Mrs. G. W. Soloman who were selected for the Surrey Cup. Miss Lintern also congratulated Mr. and Mrs. Riggall for several fine

victories and especially the latter for doing so well in the Peels and All England and on winning the Ladies Field Candlestick. Obituary

W.T.BELL.

MR. BELL, who had been an associate for many years died in October, 1965.

Since 1949 he had been a Country member of Bowdon Croquet Club where he was much liked for his pleasant though retiring personality, and his readiness to help beginners and to share with them his considerable knowledge of the game.

Mr. Bell's home club was Buxton where he was well known at the Tournaments, both as a player and as a knowledgeable referee.

He will be remembered at Bowdon for his generosity to the Club.

H.R. POULTER

THERE WILL NOT be many associates now who will re-member the name of this player whose death in February was recorded in the newspapers; for though a very successful figure in our tournaments in the years before World War II, he did not return to the game after it. He won his Silver Medal in 1910, but it was not until the mid dle Thirties that he came right to the front, being a notably successful member of the Surrey teams which were so often victorious in those years. In 1934 he won his place in the first President's Cup Ten, as he did again the following year. 1935 was his most successful sea-son, for he began the year as a member of the English team visiting Australia, came within an ace of winning the Men's Championship, and won the Open Doubles Championship with his Test team partner, E. L. Ward Petley.

Reginald Poulter was one of the most prominent of the 'swingers' of which there were fairly numerous examples at this time. He had one of the longest swings of all, and it was related of him that on one occasion, having taken a particularly extended forward swing, he caught the ball on the back swing, sending it a considerable distance. Presumably if it had chanced to make a roquet on a ball behind him he would have been entitled to take croquet from it!

IN THE sudden passing of J. K. Brown on March 21 the Budleigh Salterton Club has suffered a severe loss, and those who had the privilege of his intimate friendship, a severe blow. As to the Croquet World in general, another of those great sportsmen who have taken up our M. B. R. game, has gone from us. In his young days J.K. was a very good Lawn Tennis Player and a keen Squash Player. CAPT. H. G. D. STOKER D. S. O. RN. He was a splendid horseman, and for many years Hon: Sec: of the Albrighton Hunt. When he took up our game, THE SUDDEN DEATH of Dacre Stoker on his 81st birthday came as a great shock to his many friends in the Cro-quet World, and his cheerful presence at most of the lea-ding tournaments will be sadly missed. he soon had a formidable list of successes to his credit. In one of the late 1950s, he won the big Handicap at Eastbourne.

He served with great distinction in the Royal Navy and was the first submarine Captain to take his ship through the Dardanelles in 1915 on the day the troops disembark-ed on the Mainland, but his ship was hit and holed in the Sea of Marmara and he and his Crew spent the rest of the

war as prisoners of the Turks, an account of which he gave in his book "Straws in the Wind". For this outstanding act he was awarded the D.S.O. A fine athlete, he represented the Navy at most games, and was President of the Royal Navy Lawn Tenn is Association for many vears.

He returned from the Navy shortly after the end of the first war and made a name for himself on the stage, his best known part being the Colonel in "Journeys End" When he considered he was too old to run about the tennis court he took up Croquet and quickly made his mark in the game that gave him so much pleasure for the rest of his life.

He won the Peel Memorial as a $6\frac{1}{2}$ soon after he began to play in 1951, again in 1955, this time as $1\frac{1}{2}$, and for a third time last season at -1: But his most remarkable feat was to win a place in the President's Cup in 1964 when he was within a few months of his eightieth birthday.

No more cheerful or more generous player could be imagined, and his habit of providing a running commentary on the game as it went along, which might perhaps have seemed tiresome in anyone else, was engaging in him, since it was so wholly in character. He had a delightfully easy and rhythmical swing and was a particularly good long shot.

A matter upon which Captain Stoker was especially keen was the knitting of closer links between English and Irish players and inducing each to pay visits to the principal tournaments in the neighbouring country. In this he was notably successful and no doubt his work in this respect may bear still further fruit.

The warmest sympathy will go out from all of us to Mrs. Stoker whom it has been always such pleasure to meet at our tournaments. G. H. B. M. B. R.

Clearing out one's desk at the end of the year one sometimes discovers forgotten treasures. I have just come on a note of words written by the late R. C. Lehman in

"What after all is a Sportsman. As I understand the breed he is one who has not merely braced his muscles and developed his endurance by the exercise of some great sport, but has, in the pursuite of that exercise, learnt to control his anger, to be considerate to his fellow-men, to take no mean advantage, to resent as a dishonour the very suspicion of trickery, to bear aloft a cheerful countenance under disappointment, and never to own himself defeated until the last breath is out of his body.

Please, please, PLEASE dear Fates, let me try, let me try hard to be a Sportsman in the 1966 Croquet season, provided as an old man I may be permitted to accept de-feat just a shade before my very last breath.

There is no doubt that as a sportsman he was an example to us all.

B. TRIBUTE

Tribute is payable by non-Associates who enter any Tournaments in the list of Calendar Fixtures published in "Croquet" except the All England Handicap, the Long-man Cup, and the Inter-Counties Championships, at the following rates:

(a) 25/- per Tournament, or

- 12/6 for one event only per Tournament.
- (b) 10/- per Evening, Weekend, or other Short Tourna-ment, or 5/- for one event only per Tournament in this category.

NOTE

1. Evening Tournaments are those which start at 4 p.m.

or later and which do not last longer than one week 2. Weekend and other Short Tournaments are those which do not exceed four days' duration.

3. Regarding category (b) above, the words "one event only" apply both to the player and to the Tournament itself, that is to say a non-Associate entering one event only in a multi-event Tournament is liable for Tribute at 5/-; and if a Tournament consists of one event only the liability of each non-Associate entrants is 5/-
