AUTHORISED VARIATION FOR HANDI-CAP PLAY

Tournament Committees, in arranging their programmes for 1953 are invited to adopt the following variation in any event to which it may apply. This variation has been authorised by the Council with the purpose of accelerating play between competitors in the higher bisqued categories, and will be applicable to class "D" in the Gilbey Cup next August.

In a handicap event divided into classes, where any class is restricted to players with handicaps of 4 bisques or over, each competitor shall be allowed to take all the bisques to which he is entitled, less 4.

It is hoped that an extensive trial will be given to this variation, which for convenience may be referred to as Variation H.

Applications for increase of handicap may be made to the Secretary C.A. Applicant must furnish supporting evidence for sub-mission to the Handicap Co-ordination Committee.

EDITORIAL NOTES

The Play's the Thing

As in previous years, our thanks are again due to the Tournament Committee for their work in arranging an attractive programme of fixtures for 1953.

These opportunities for competitors are many and the tournaments are widely distributed over the country. So far so good—the stage is set, the players are anxiously awaited.

We say anxiously because the C.A. Council, like the governing body of games generally, has to study the financial side of croquet very seriously—if not, in these days, with some trepidation.

Obviously, therefore, however attractive the programme provided by the Tournament Committee may be, unless it draws to the numerous meetings a substantial number of players—sufficient to keep the game itself in being—their labour in providing Tournaments will have been in vain.

In case we have seemed pessimistic, let us add the encouraging fact that the adverse balance shown on the accounts for the year ended 31st December, 1951, has been wiped off.

This is actually due to the increased levy, and reveals the wisdom of the Finance Committee in recommending the increase. Let us see to it that this season there will also be a still further increase in the number of competitors at Tournaments.

The Best Players

The above heading may at once conjure up the question as to who are the best players of today. Obviously we must be able to answer this question more easily nowadays than when the number of players were vastly more numerous.

Today the eminently best players can be counted on one hand—and, we venture to add, including those of both sexes.

Originally the "Ladies' Field' Cup was presented by the proprietors of the publication of that name in 1911, to be competed for by the ten best ladies; that number was maintained for 10 years. Then for the next eight years only eight took part; but the following seven years ten ladies again competed. Since 1946 only eight competitors were invited to play for this handsome trophy.

It is somewhat disappointing now to read in the very informative article by Mr. M. B. Reckitt, Chairman of the Tournament Committee, that there will only be six competitors this year in the "Ladies' Field" Cup.

Though in the President's Cup, since the war, only eight have competed for it, there are no doubt adequate—if not obvious—reasons for this. Perhaps a glance at the Year Book will be enough to give some indication as to who are the best players of today.

We mean, of course, judging by the order in which the competitors in both the "Ladies' Field" Cup and the President's Cup finished during the last half a dozen years.

Croquet in South Africa

The following letter to our Secretary may interest readers:—

Dear Mrs. Apps,

I have been playing quite a bit of croquet out here, though it was only by luck I heard they played at all in the Transvaal; and even the Durban people didn't know if they still played up here.

I had one game at Cape Town with Capt. Belcher where there are three gravel courts—but very moderate ones, and not really much fun. I hear now there are two good gravel courts at King William's Town, and two at East London.

I played on a rather coarse grass court at Pietermaritzburg, where they had two; and I heard of a very good grass court at Pinetown, twelve miles north of Durban, and there are two clubs in Durban with two gravel courts each, but I had no time to see them.

Near Johannesburg there are two good gravel courts, two very good gravel courts at Benoni, and two at Brakpan. At Pretoria, in Eastwood Park, there is one of the best level grass courts I've ever played on; it was a real joy after gravel, and as good as Hurlingham or Roehampton.

The bowling greens out here are superb, and I long for a game of croquet on them!

I'm afraid croquet is dwindling out here—they think it's an old women's game. Golf and bowls are the popular games.

I thought all this might interest you and any Associates who may come out here; the clubs are most hospitable and welcome visitors.

News from U.S.A.

Mrs. R. R. Williams, a keen Associate and player, who was over here some time ago from her home in Philadelphia sends the following cutting from the New York Wall Street Journal:

Old Faithful Croquet

One of the surprises of the show was the sudden popularity of that old faithful croquet. Paul J. Mac-Mahon, president of Crane and MacMahon, of St. Mary's, Ohio, claims the game—relegated to homes for the aged a short four or five years ago—has come back so sharply that his sales are at least 1,000% above the level of two years ago. Mr. Morley L. Moore, general sales manager of the Wilson Sporting Goods Co. of Chicago, says: "People are turning more to personal activity sports, away from the big spectator games."

Edinburgh Croquet Club-Inaugural Dinner

With the object of preventing Members losing complete touch with each other during the winter season, the Edinburgh Croquet Club, founded in 1950 by Mr. Moray McLaren, the well-known author and broadcaster, held a most successful Dinner recently in the Roxburghe Hotel, Edinburgh.

Club Membership last season was 47, but, including guests, a company of 51 partook of an excellent meal. A novel feature was the miniature crest of a croquet ball surmounted by two crossed mallets which had been skilfully inscribed on the Menu cards by a daughter of one of the Members.

As President, Mr. McLaren occupied the Chair, and, in a delightfully informal style, said he scarcely anticipated when making the first tentative proposal for a Club nearly three years ago that such an enjoyable evening would be one of the unexpected results. He reminded those present of their extreme good fortune in being able to play in such unique surroundings of sylvan beauty as the grounds of Lauriston Castle, overlooking the Firth of Forth. He also remarked on the popular misconception of croquet as being a graceful game of the Edwardian era, mainly suited for ladies. By this he did not in any way belittle the extraordinary enthusiasm of the ladies of the Edinburgh Club, but he thought it had been proved again that both ladies and gentlemen could find equal pleasure in the deep strategies of the game.

The Club's Benefactor

Honorary President of the Club is Sir Andrew Murray, a former Lord Provost of the City, who was present as Guest of Honour along with his sister, Miss Rodney Murray. The Toast of "Our Guests" was proposed by Mr. R. J. B. Sellar, radio playwright and author, who, in a happy little speech, referred to the Club's great indebtedness to Sir Andrew for the invaluable assistance he gave during his term of office in securing the Club's green and premises at Lauriston Castle, which is on property owned and controlled by the City authorities.

Sir Andrew briefly replied, and the concluding speech was made by Lord Mackay, a senior member of the Scottish Courts who is an extremely active member of the Club. In proposing a vote of thanks to the Chairman, Lord Mackay referred to Mr. McLaren's many literary accomplishments as well as to his provess on the green.

The Edinburgh Club owes much to one of its Members, Mrs. J. D. Steel, who originated the whole idea of a Dinner, which is now likely to become an annual event.

COUNCIL MEETINGS

Minutes of a meeting of the Council held at 4 Southampton Row, on Thursday, November 20th, 1952.

Present.—Chairman, E. P. Duffield, Col. C. C. Adams, C. B. Bird, Rev. B. V. F. Brackenbury, D. E. Buckland, Col. J. G. Clarke, L. F. C. Darby, G. V. Evans, Miss D. A. Lintern, Mrs. L. E. G. Nickisson, M. B. Reckitt, Mrs. E. Reeve, Brig. H. C. N. Trollope, Mrs. G. J. Turketine, B. H. Wiggins, Dr. W. R. D. Wiggins, H. F. Crowther-Smith (Editor C.A.G.), Mrs. L. C. Apps (Secretary).

The Chairman welcomed Mr. N. L. Bright and Brig. H. C. N. Trollope newly co-opted members of Council.

- 1. The Minutes were read, confirmed and signed by the Chairman.
- 2. A letter from the Rev. G. F. H. Elvey was read suggesting that the *ad hoc* Committee formed about three years ago to deal with instruction in the clubs should be disbanded. On the proposal of Col. Adams, seconded by Mr. Bird this was agreed.
 - 3. A vacancy on the Council was declared.
- 4. The Rev. B. V. F. Brackenbury proposed the motion standing in his name, and adjourned from November 6th. He asked leave to add three words to it. Consent being given the motion read: Addition to Regula-15 "to call attention at once to any infringement of the Laws and to appoint, at his discretion, two of the assistant referees to have similar powers." This was seconded by Mr. Reckitt. After considerable discussion the Chairman suggested that the clause be added to Regulation 15 (e) as a variation for 1953, so that it might be given a trial before being embodied in the Regulations. With this proviso the motion was put to the vote and carried.
- 5. Motion by Mr. E. P. Duffield: To consider the present handicapping procedure and, if deemed necessary, offer guidance thereon to the Handicap Co-ordination Committee. Members with handicapping experience gave their views. There was general agreement that while wholesale raising of handicaps was to be deprecated, individuals who found themselves unable to play to their handicaps should be encouraged to apply for an increase. Also that a conservative policy should be followed in reducing handicaps.
- 6. It was decided to cancel the December meeting of the Council.

Minutes of a meeting of the Council held at 4 Southampton Row, on Thursday, January 1st, 1953.

Present.—Chairman, E. P. Duffield, Col. C. C. Adams, Mrs. R. C. J. Beaton, C. B. Bird, Rev. B. V. F. Brackenbury, N. L. Bright, D. E. Buckland, Col. J. G. Clarke, E. P. C. Cotter, Major J. H. Dibley, G. V. Evans, Miss D. A. Lintern, Mrs. L. E. G. Nickisson, M. B. Reckitt, G. W. Solomon, Mrs. G. J. Turketine, B. H. Wiggins, Dr. W. R. D. Wiggins, Brig. H. C. N. Trollope, W. Longman, H. F. Crowther-Smith (Editor C.A.G.), Mrs. L. C. Apps (Secretary).

Apologies for non-attendance were received from L. F. C. Darby, N. Oddie and Mrs. E. Reeve.

- 1. The Minutes of the last meeting were read, confirmed and signed by the Chairman.
- 2. The Secretary read a letter drafted by Mr. Darby, which he proposed should be sent to the Treasurer of the Eastbourne Corporation on the subject of the Account for the Eastbourne Tournament. This was approved.

A letter was read from the Secretary of the Wimbledon Lawn Tennis and Croquet Club in which it was stated that only two full sized croquet courts could be laid out on the club grounds. As this rendered the venue unsuitable for holding the President's Cup competition at Wimbledon, Mr. M. B. Reckitt proposed that exhibition games should be staged on the two full sized courts on Saturday, September 12th. Miss D. A. Lintern suggested that Monday afternoon would be preferable, and Mr. Buckland

also spoke in favour of Monday. After discussion it was decided that application be made for the use of the courts for Monday afternoon, and the opening day of the President's Cup competition postponed till Tuesday.

- 3. Mrs. Beaton gave notice of motion "That a novices' event should be played at most of the large tournaments especially country meetings for players 7 or 8 and over. A shortened game, handicaps, entry fees to be from 3s. to 5s.
- 4. The venue for the Annual General Meeting was discussed. Mr. M. B. Reckitt proposed that it be held during the Peel Memorials week at Roehampton. This was seconded by Mrs. Nickisson. Major Dibley proposed that it be held at Hurlingham during the Inter-County Championships meeting. This was seconded by the Rev. B. V. F. Brackenbury and on being put to the vote was carried.
- 5. MacRobertson Trophy. It was decided that an ad hoc Committee be appointed to deal with all questions as to issue of challenge and any further arrangements. Messrs. Duffield, Adams, Reckitt, Darby, Brackenbury and Solomon were selected.
- 6. Mr. Reckitt submitted a statement on handicapping policy for approval by the Council, and it was agreed that this should be published in the April C.A.G.

A special meeting of the Council was held in accordance with Rule XIV. Col. Adams moved that the amendments to the laws be agreed. Mr. Longman asked that the amendment to Law 24 (b) be taken separately. The other amendments having been passed, Mr. Longman moved that Law 24 (b) remain as at present. This was seconded by Mr. Evans, and after considerable discussion put to the vote and carried.

The Council records with profound regret the death of two of its members during 1952.

Mr. G. L. Reckitt had been a member of Council from 1923 to 1926 and again from 1947 to 1952. He was Chairman of the Laws Committee 1947-49 and Chairman of the Council 1950-52. His valued advice and untiring efforts in the interests of the game will be greatly missed.

Major J. B. Moffat was co-opted a member of Council in 1946. He always took a keen and constructive interest in the affairs of the Association, and until prevented by ill-health, was a most regular attendant at Council meetings.

Another vacancy, in happier circumstances was occasioned when the Rev. G. F. H. Elvey accepted the invitation of the Council to become a Vice-President of the Association. Mr. Elvey, who qualified for a silver medal in 1904 has a very long-standing connection with the game. His continued active interest in all pertaining to it will undoubtedly make this a popular appointment.

Two of the vacancies of the Council have been filled by the co-option of Mr. N. L. Bright of Nottingham, and Brigadier H. C. N. Trollope of the Colchester Club. It is always a cause for satisfaction when Associates from the provinces feel able to serve on the Council, as it is most important that the views of the provincial clubs shall be well represented. It is perhaps not fully appreciated that such representation can only be given at a very real sacrifice of time and money on the part of those who are willing to come long distances to attend Council and Committee meetings.

Although fifty-five new Associates were elected in 1952 as against thirty-four in 1951, there has been a further slight drop in membership. This is largely attributable to deaths.

One new club—the Edinburgh Croquet Club and the old established club at Littlehampton have become affiliated to the C.A. Any Associate who knows of an unaffiliated club should endeavour to get it added to the registered list. There is no charge. The advantage is that it enables the Secretary of the C.A. to advise inquirers as to local facilities for play, and such inquiries are increasing in number, and gives such clubs the opportunity of getting in touch with the C.A. They may also benefit from visitors fees which they might otherwise not get.

The Council has decided to resume the distribution of medals to overseas Associations. The Australian Croquet Council, the New Zealand Croquet Council, and the South African Croquet Association will each hold an annual competition for a silver and a bronze medal to be competed for under such conditions as they may severally determine.

As will be seen from the Accounts, in lieu of the adverse balance of the previous year there is a small sum on the credit side. This is due to the increased Levy, and the Council feels that the Finance Committee is to be congratulated on having made this recommendation. An increase in membership, however, is still the true basis for a sound financial position.

The Council desires to thank all those who have acted as Managers, Referees and Handicappers during the past season. Their services in these most important capacities are universally appreciated.

NOTES ON ALTERATIONS TO LAWS, Etc., 1952-53

We had hoped that by this time, the Council would have decided whether the game of Association Croquet is to be played with the four lifts provided for in Law 44, or whether we are to be satisfied with two lifts only, as now laid down in Variation B. This knotty problem is still under discussion, and we must, therefore, play our level games during 1953 under the existing laws, but we are assured that this matter will be settled one way or the other before we come to the 1954 season.

The alterations which are coming into force this year are small, almost microscopic, so far as Association Croquet is concerned, but players will be glad to find that the diagram giving the dimensions and lay-out of the Court, has been moved from Appendix A, and will in future be printed opposite Law 1, where it properly belongs. There are slight alterations to the wording and punctuation of Laws 10 (b) and 36 (a) (ii), but these do not affect the play in any way.

A proposal to alter Law 24 (b) has been discussed, but it has not been accepted by the Council and the Law will, therefore, remain unaltered. Part of this Law reads as follows: "When a ball in play is sent off the court within one yard of the corner, the striker shall at once place it so that it rests on the corner spot. If it cannot be so placed, the striker shall place it on the yard-line as near as possible to the corner spot." The meaning of this is that if a ball is on the yard-line an inch or two out of the corner, a ball coming into the corner is placed on the yard-line, touching it and "across" the corner. It has been a custom with many players to interpret this law loosely, and place one ball on the corner spot and the other touching it on the yard-line. The proposed amendment was an attempt to make the law conform with this practice, but now that it has not been accepted, it is hoped that players will obey the law and remember that in such cases, the balls must be placed diagonally across the corner.

The Laws of Golf Croquet have been altered to provide for a new system of handicapping by bisques and halfbisques, which, it is hoped, will prove satisfactory.

There is a new paragraph on the Etiquette of the game which refers especially to tournament play, and is of some importance. It directs the winner of a game to return at once the balls to Baulk-line A, and replace the clips on the first hoop. He is also, without delay, to report to the Manager the result and score. Incidentally, it might be as well to draw attention to the common failure of players to remove from the peg the clip referring to a pegged-out ball.

Finally, a short reference should be made to two temporary regulations which are being tried out this year as an experiment. They are not at present being incorporated in the Regulations for Official Tournaments, but this will probably be the case next year if they prove successful. The first refers to handicap events divided into classes, where there is a class for competitors with a handicap of 4 bisques or over. In that case, it may be decided by the Committee of the Tournament that in that event, each competitor may take all his bisques less 4. It is hoped that this variation will tend to speed up the play in such events. The second temporary regulation gives powers to the Referee of a Tournament to call attention at once to any infringement of the laws and to appoint, at his discretion, two of the Assistant Referees to have similar powers. We hope that this proviso will have a salutary effect on the careless player who is inclined to commit such misdemeanours as "shepherding" and "double-tapping."

The Official Handbook of the Laws is now being reprinted. Every Associate should make sure that he or she possesses an up-to-date copy.

C.A. HANDICAPS—A STATEMENT OF POLICY

The Council, on the initiative of the Handicap Coordination Committee has recently had the whole question of C.A. Handicaps under consideration and has arrived at the following decisions:—

- 1. Though it is inevitable that from time to time (as on three previous occasions) the scale of handicaps should be altered if a "Minus" handicap is to retain any significance, it is not proposed to make any further alteration of this sort in the immediate future.
- 2. As already announced, Associates who desire an increase in their handicaps are invited to apply for this to the Secretary C.A. giving evidence in support of their application and specifying the tournaments at which they have recently played. It is not the present policy of the Committee to raise the handicaps of individual Associates unless such an increase is applied for.
- 3. It is of course open to Club Handicappers to allot to their members, for play in their own clubs, any handicap they think fit. They are asked, however, to be circumspect in giving new handicaps to competitors in preparation for C.A. Calendar Fixtures, and in particular to avoid allotting to players, who show obvious promise of rapid improvement, handicaps likely to be in excess of their potentialities.
- 4. In view of the smaller entries at tournaments by comparison with those of pre-war days, it is felt that the rate at which handicap reductions are now made ought to be somewhat slowed down. During the forthcoming season reductions will be made more sparingly and will have to be earned by a more consistent level of performance than has been required hitherto.

This statement of policy is made for the information of Associates, and is to be taken as without prejudice to the practice of reducing as promptly as possible those players who by virtue of rapidly improving form show that they are in need of this.

Tournament Handicappers will assist the Committee if they make their recommendations in accordance with the policy outlined above.

THE TOURNAMENT SEASON

SOME ALTERATIONS—AND THE REASONS FOR THEM

This article is written to call the attention of Associates to certain changes in the dates and conditions of some of the fixtures for which the Council is responsible. Though it would in fact be possible for any sufficiently attentive reader of the "Gazette" during the "close season" to extract all the information about to be given here for himself by a study of the minutes of Council meetings and of the programmes of C.A. tournaments, it is doubtful whether more than a handful of Associates attempt anything of the kind. Hence the facts—and the reasons for them—are here set forth so that only the most negligent reader will find himself without the information which he needs (and presumably desires) to have.

A preliminary reference may be made to the official statement on Handicapping policy put out by the Council which appears elsewhere in this number. If Associates will study this carefully not only will they discover some things which they ought to (but too often do not) know already, but they will find information which will help them to understand matters in the future which might otherwise appear to be puzzling.

Taking the new features in the order in which they occur in our Calendar, we come first to a new condition (i.e.) under which a player may qualify for a county team. The purpose of this will, it is hoped, be obvious. It is twofold: to widen the area from which Collectors may draw in mustering their teams, and so far as possible to prevent exclusion from the competition of good players who do

not happen to possess a birth or residential qualification for those counties which enter for it.

The next point is one that was announced as much as eight months ago. The occurrence of the Coronation in the first week of June makes it necessary to suspend for this season the convenient arrangement by which the "Caskets" week has of late years followed upon County week. The dates of some provincial tournaments have been adjusted accordingly. Associates may notice that the honourable and ancient titles of what it has become convenient to call "the Caskets" have been restored at the head of this programme, to recall the fact that these events carry with them the Men's and Women's Championships—the latter a title which goes back as far as 1869. Again, it has been thought more appropriate to play both the Mixed and the Open Doubles Championships under Law 44, without any modification, so that competitors will be entitled to as many "lifts" under this Law as their opponents give them the opportunity of enjoying.

We come next to the most far-reaching of all this season's alterations, and one that was only decided upon after prolonged consideration. The competition for the Ladies' Field Cup is one that has of late years given rise to some difficult problems. This tournament is played in a week when it is often very hot and the courts at Hurlingham fast and tricky. In consequence games have become very long, and even a few such dislocate the schedule and require play to be continued to an unreasonably late hour, even on occasion till nine o'clock. As a result the competition has been felt by some of the best lady players to be so tedious and exhausting that they have become reluctant, or even physically unable, to enter for it. Since the essential purpose of the tournament is not fulfilled unless the very best lady players do in fact compete in it, it has been decided this year to limit the competitors to six. Since this cannot involve more than two games a day, it is hoped that all those invited will in fact accept and the prestige of the trophy be thus fully maintained.

There is another, though relatively minor, alteration in the programme for this week. It was pointed out last year that this is for some Associates the beginning of the holiday season in which alone they are free to compete in tournaments, but that previously there has not usually been any opportunity for minus players to do so, since the Silver Jubilee Cup was not instituted (and was never intended) for them. Accordingly this competition, previously played at Hurlingham, has been put forward to the President's Cup week at Roehampton early in September, when the Golf Croquet competition will also be played. Instead the Creyke Cups will be competed for and in two blocks, so that every type of croquet player will now have this opportunity of play before the big tournament which follows at Hurlingham in the first week of August.

It will be noticed that the President's Cup will begin a day later than usual this year. There is a reason for this of the greatest interest. The suggestion had been made that the "Best Eight' should play their great contest at Wimbledon, thus recalling the earliest days at Worple Road, before Lawn Tennis was heard of. The A.E.L.T.C. committee received our rather daring suggestion with the greatest cordiality, and it was hoped that the President's Cup could be played there during the week of the Junion Lawn Tennis Championships. This, it was felt, would give an unparalleled opportunity for publicity, both on the ground itself and in the press. But unfortunately several difficulties arose, the chief of which proved insurmount-able, namely that no playing area was available for more than two full-sized courts. Accordingly the Best Eight will play as usual at Roehampton, but on the Monday of the week allotted to this competition four of the most outstanding of these will play exhibition games at Wimbledon, attracting, as we may hope and expect, a degree of interest which it would be hard to arouse in any other way.

A brief reference may be made in conclusion to two other matters. First, it has been found of recent years that the attempt to play the early stages of the Longman Club Team Cup in Areas is barely feasible and leads to results which are sometimes inequitable. Accordingly all teams entering will this year be included in a single draw. As will be seen from the new conditions, the Manager will make every

endeavour to see that the result works out as fairly and conveniently as possible.

Finally, it is proposed to send over in mid-August a fully authorised English team to compete first in the Irish Championship, and then in a Match against a team representing that country. It is hoped to initiate a series of such matches, and to welcome an Irish team here in 1954.
